## What is my status?

Determine where your farm business is sitting to understand your next steps for NZFAP Plus. See the following status examples:

### I am not NZFAP certified and haven't started anything involving farm assurance.

Get in touch with your ANZCO Foods Livestock rep or the Quality Assurance (QA) team to get started with NZFAP.

### My farm is NZFAP certified.

## What are the different stages of NZFAP Plus, and what do they give me?

### Membership

You officially become a member of NZFAP Plus once you have completed the self-assessment.

NZFAP Plus membership gives you access to a variety of deals to help you through the process including two hours of free consulting with Agri Intel to give you a clear plan and indication on your next steps. Contact the ANZCO Foods QA team to learn more.

### Silver or Gold certification

Your farm is NZFAP Plus certified once you complete an audit and receive a certificate.

There are two tiers of certification: Silver and Gold. The tier you achieve depends on the requirements you meet and what you are personally aiming for; however, the benefits offered by ANZCO currently remain the same for both tiers.

As an ANZCO Foods producer, NZFAP Plus certification (Silver or Gold) gives you:

- **A premium** on contracted, in-spec lamb, prime steer/heifer, and bull
- **Double Advantage points** if you are, or become, a member on contract
- **\$1,000 rebate** for the first 50 farmers certified from 1 January 2025
- **Plus** knowledge and understanding of your farming systems to future proof your business and make informed decisions

## How do I become NZFAP Plus certified?

### Step 1

Your farm must be NZFAP certified to apply for NZFAP Plus.

### Step 2

Fill out an NZFAP Plus application form and send the completed version to the ANZCO Foods QA team. You can find these forms on [www.nzfap.com](http://www.nzfap.com) or contact the ANZCO Foods QA team.

### Step 3

You'll be emailed a digital self-assessment by QCONZ once you submit your application form. This steps you through the requirements and helps you understand what you may still need to work on. **Once you complete the self-assessment, you're officially a member of NZFAP Plus.**

### Step 4

Once you become a member, you can request an audit with the QA team when you feel ready. It is important to note there is a 4 to 8 week wait time to get an audit booked, so this must be considered when requesting an audit. The QA team has a range of support and resources available to assist you along the way. Refer to the back page for more information.

### Step 5

Once you have successfully completed an audit, you are NZFAP Plus certified (either Silver or Gold). The audit will reoccur every three years from the date of certification.
